I. ALCOHOL FINDS IN PRISON

- 1.1 Between January 2016 and March 2018 there were 8,133 incidents where alcohol was found in prisons in England and Wales. ¹
- 1.2 There were 227 alcohol finds in Welsh prisons in 2017.
- 1.3 Despite holding just 48% of the total prison population in Wales, 84% of all alcohol finds were at HMP Parc in 2017.

1.4 HMP Parc (11 per 100 prisoners) recorded the highest rate of alcohol finds in Wales in 2017. The second highest rate was at HMP Swansea (3 per 100 prisoners) followed by HMP HMP Cardiff (1 per 100 prisoners).³

1.5 There were more alcohol finds at HMP Parc in 2017 (191) than at HMP Altcourse (22), HMP Birmingham (45), HMP Oakwood (110) and HMP Rye Hill (10) combined.⁴

2. DRUG FINDS IN PRISON

- 2.1 There were a record 656 drug finds in Welsh prisons in the year ending March 2018.5
- 2.2 While the number of prisoners held in Wales (excluding HMP Berwyn) has increased by 9% since 2013⁶, there has been a 475% increase in the number of drug finds in Welsh prisons during this period.⁷
- 2.3 The number of drug finds in English prisons increased by 200% between 2013 and 2018.8

2.4 There were 46 drug finds at HMP Berwyn in the year ending March 2018.

2.5 During 2018, HMP Swansea (26) had the highest number of drug finds in Wales per 100 prisoners. HMP Parc (22 per 100) recorded the second highest rate followed by HMP Cardiff (21 per 100) and HMP Berwyn (6 per 100).9

Justice do not provide a separate population breakdown for HMP Prescoed and HMP Usk. The combined rate, however, is 2 per 100 prisoners at HMP Usk/Prescoed.

3. HOMELESS AT PRISON RECEPTION

3.1 A quarter (24%) of all prisoners presented as homeless entering prison in Wales in 2017.¹⁰

3.2 In spite of an increase in the number of prisoners who presented as homeless in Wales in 2017, the percentage marginally fell between 2016 (24.8) and 2017 (24.3).

4. HMYOI PARC: SAFETY IN CUSTODY12

- 4.1 The Young Persons' Unit at HMYOI Parc is a facility managed by G4S on the same site as HMP Parc in Bridgend. The Unit holds boys under the age of 18 and has a Certified Normal Accommodation of 64 (HMIP, 2018a).
- 4.2 In 2017 there were 40 children being held at the Young Persons' Unit.13
- 4.3 14 children from Wales were held at the Young Persons' Unit in 2017. 65% of young people held at the unit were from Youth Offending Team (YOT) regions outside of Wales.
- 4.4 Serious concerns were raised in HMIP's annual report for 2016/17 about the safety levels within custodial institutions for children across England and Wales. Within his most recent annual report, HM Chief Inspector of Prisons (2018b: 33) identified that children "continued to feel unsafe" in Young Offender Institutions in England and Wales.
- 4.6 Following an inspection of HMYOI Parc in October 2017, HMIP (2018a) reported that in the six months leading to September 2017, 23 boys had carried out 35 acts of self-harm.

¹² Imprisonment in Wales: A Factfile (published in June) presented figures taken from the Ministry of Justice's Safety in Custody Statistics bulletin. The figures for self-harm, prisoner-on-prisoner assaults, assaults on staff and disturbances at HMP Parc included incidents recorded at the adult and Young Persons' Unit. I was informed by the Ministry of Justice in March 2018 that incidents at both facilities are aggregated because they do not have a "simple way of separating incidents involved under-18s from those involving adults".

¹⁴ The Youth Justice Board state that data from April 2017 onwards are unpublished and unvalidated. These figures are not routinely published at establishment level and data received from the establishments through monthly returns is validated through a reconciliation process on an annual basis. The data from April 2017 onwards have not yet gone through the reconciliation process. These explanatory notes accompanied the data that were obtained from the Youth Justice Board via the Freedom of Information Act 2000.

¹⁵ According to the Youth Justice Board, the sum of the number of victims may not equal the number of incidents of assault. This is because one incident of assault may have more than one victim.

4.7 There were 64 incidents of self-harm recorded at the Young Persons' Unit in 2017.

4.8 Although the Ministry of Justice's *Safety Statistics in Custody* data fail to provide a disaggregated breakdown of incidents at the adult and Young Persons' Unit at HMP Parc, data recently obtained from the Youth Justice Board show that the rate of self-harm per 100 prisoners only marginally decreases when the number of incidents recorded at the unit in 2017 are subtracted.

4.9 HMP Parc (adult only) recorded the highest rate (90 incidents per 100 prisoners) of self-harm in Wales in 2017. The second highest rate was at HMP Swansea (68 per 100 prisoners) followed by HMP Cardiff (33 per 100 prisoners) and HMP Usk and Prescoed (2 per 100 prisoners).¹⁷

¹⁶ The Youth Justice Board state that the victim of a proven assault can either be recorded as 'Victim was a young person' or 'Victim was NOT a young person'. 'Victim was NOT a young person' includes any staff members or visitors who were the victim of a proven assault. Due to the way the data are collected it is not possible to breakdown the victim was NOT a young person category further into staff members or visitors.

¹⁷ The average populations were worked out using population levels from March, June, September and December 2017 – HMP Cardiff (745), HMP Parc (1,686), HMP Swansea (442) and HMP Usk/Prescoed (528).
