

## An Open Access Glossary

Term	Description
Open Access (OA)	OA is the free and unrestricted availability of full-text research material on the internet, allowing users to access research with no technical, legal or financial barriers.
Gold route or Gold OA	A gold OA article is published immediately in an online journal and is available to all. To cover costs, publishers usually charge a fee to the author or institution (see APC). The version available is the final formatted version.
Green route or Green OA	A version of the output (usually the post-print) is stored in an institutional repository (e.g. Cardiff University's repository <u>ORCA</u> ) and/or in a subject-based repository (e.g. <u>ArXiv</u> , <u>PubMed Central</u> )
Hybrid Journal	Authors can choose between the 'traditional' method of access to articles via subscription or making the individual article open access. Publishers will charge authors, their institutions or funders an additional fee for making an article OA.
Pre-print	The submitted, pre-peer reviewed versions of research articles. Most publishers allow these versions to be deposited in an institutional repository.
Post-print	The final, corrected, peer-reviewed version of the article, without the publisher's formatting and branding. Many publishers allow these versions to be deposited in an institutional repository (sometimes after an embargo period). Sometimes called the Author's Accepted Manuscript (AAM).
Self-archiving	This refers to the author depositing a full-text version of their research into an institutional and/or subject repository in order to maximise accessibility, usage and citation impact.





Embargo	Some publishers have restrictions on when the author version of an article can be made publically available in a repository. This can vary from 6 months to 2 years after publication. If research is funded or is to be submitted to the post-2014 REF, maximum embargo periods apply. See below for details.
RCUK mandates	<u>RCUK policy</u> is that all research funded by them (including PhD theses) should be made available Open Access. The RCUK preference is for gold OA, but they do support a mixed approach; the decision on which OA route to follow is taken by the individual author/institution. If the gold route is not available or appropriate, RCUK requires green deposit for a funded research output within 6 months of publication (STEM subjects) or 12 months (AHSS). Central funding is available to pay for Gold OA for RCUK funded authors. Contact <u>openaccess@cardiff.ac.uk</u> for more information and advice.
Charity Open Access Fund (COAF)	A partnership between the Wellcome Trust, Arthritis Research UK, Breast Cancer Now, British Heart Foundation, Cancer Research UK and Leukaemia & Lymphoma Research, COAF supports unrestricted access to publications wholly or partly funded by these charities and institutions. They will provide grant-holders (via their institution) with additional funding to cover OA charges where appropriate. Contact <u>openaccess@cardiff.ac.uk</u> for more details.
HEFCE post-2014 REF OA policy	All articles and published conference proceedings must be available in an open-access form to be eligible for the post-2014 REF. The authors' final peer-reviewed manuscripts must have been deposited in an institutional or subject repository on acceptance for publication. Any embargo cannot exceed 12 months (STEM) or 24 months (AHSS). The post print can be exchanged for the published version if copyright allows. No specific licence is required for APC-funded Gold OA.
